

JANUARY 2023 UNHOUSED SURVEY

The City's Multi-agency Outreach Resource Engagement (MORE) team partnered with the Nevada Department of Transportation (NDOT) to collect information about unhoused people that live near the I-515/US 95 freeway in the Downtown Access Project (DAP) limits. The MORE team surveyed 76 individuals from January 18 through January 31, 2023. The team explained to the individuals that NDOT is studying some design options to reconstruct the freeway which may remove the existing bridges Since these proposed design options may affect the residents and businesses near the freeway, NDOT wants to learn more about the unhoused people. The team assured the individuals that the survey results are completely anonymous. Each participant was thanked for their time to complete the survey with a \$10 gift card to 7-11. The time to complete one survey was typically less than 10 minutes.

SUMMARY OF FINDINGS

The busiest intersections of I-515/US 95 with local streets for day and night-time use are Maryland Parkway, 15th, 16th and 21st Streets. The unhoused people in these areas report long-term use of the underpasses. The underpasses provide a sense of safety and security and are conveniently located near popular services like meals, case management, physical healthcare, and showers/bathrooms.


When asked where they would go if the current location was closed, many respondents indicated they would go somewhere nearby due to the proximity to services. There was also a high rate of reported rejection of any social services. In describing services that are desired but unavailable, the highest-ranking choice was housing services. Although not one of the multiple choices, another popular request was for IDs/identification replacement and SNAP/EBT (benefit) cards. This may be attributed to the frequent clearing of the areas.

The most frequented place they visit, three times more than any other place, are 7-11 stores. The next most popular place to visit is other kinds of stores and markets which, in general, are further from I-515/US 95. 63% of the respondents reported walking as their mode of transportation.

The demographics of the unhoused population in this area do not mirror the demographics in the study area. The overall minority population is lower amongst the unhoused than the study area (47% of the unhoused population compared to 55% for the study area), but this includes a large Black or African American population, which is also not reflective of this neighborhood. The respondents had a large percentage of reported disability (42% of those surveyed compared to the Census average of 18% for the study area).

FINDINGS


Number of surveys collected: 76

Answers ranged from 1 day to 15 years. The median or middle number of all the responses on duration was 4 months. Average duration was 623 days or 21 months.


11. How old are you?






12. Including yourself, how many adults and children are staying with you overnight? Answers ranged from 0 to 6 with an average of 1.25 and a median of 1.00.


13. How do you identify your race?




